The first Vietnam Veterans Day, declared by President Richard Nixon in 1974, coincided with the one-year anniversary of the withdrawal of U.S. combat forces from Vietnam on March 29, 1973.
    - President Donald J. Trump signed the Vietnam War Veterans Recognition Act of 2017 on March 28, 2017 to officially recognize March 29 as National Vietnam War Veterans Day.
