Opening of the Tuolumne County Board of Supervisors Chambers

Effective MAY 4, 2021, Board meetings will be open to the public. The following modifications will be followed to allow for a safe opening:

- Everyone in the Board chambers will wear a face-covering at all times.
- Capacity will be limited to no more than 50 persons.
- After a guest speaks, they will be asked to exit the Chambers to allow other speakers in.
- Tables have been removed, and chairs will be set-up with appropriate distancing.

Members of the public may participate in the meetings in person in the Board room. Should the number of people reach 50, individuals will be given the option to watch the Board meeting in the 4th floor lobby or in the County Administrative Office conference room. Individuals will be allowed into the room to comment on items and will be asked to leave the Board room after.

Members of the public will be allowed to call in to the meeting for public comment if they do not wish to be physically present. The call- in comment process will continue to be available as follows:

The Board Chair will ask members of the public physically present to make comments first and then he will ask members of public on the phone to comment.

Citizens who wish to comment via the phone should be prepared to use our call-in line at (209) 533-6581 to queue for verbal public comment. Public Comment will be opened and closed individually for each agenda item listed below. If you wish to comment on a specific item, please call in when the Board Clerk has read the item. The Chair will ask if there are any comments from the public and at that time your call
