## **Zoom for Public Comment for Tuolumne County Board of Supervisors Meetings**

In an effort to provide the Public with the continued ability to provide public comments remotely and be responsible stewards of County financial resources, the following modifications have been made to the Public Participation Procedures for the Board of Supervisors Meetings. These changes are effective November 09, 2021.

In order to protect the health and safety of our Tuolumne County citizens, this Board meeting is open to the public with modifications. Face coverings are required for all attendees regardless of vaccination status. During the Board meeting, citizens who wish to provide public comment will be invited to do so by the Board Chair. Citizens who are physically present will be called first. Citizens who are not present and wish to provide remote public comment via Zoom may use the 'Raise Hand' feature on their computer or press \*9 if participating by phone to enter the queue. The Moderator will read the last four digits for phone-only participants in lieu of name.
