

AMENDMENT #1 TO  
THE STANDARD AGREEMENT FOR PROFESSIONAL SERVICES  
NDP CONSULTING SERVICES FOR THE GROVELAND CRC PROJECT

This Amendment #1 ("Amendment #1") is entered into this <sup>NDP</sup>2<sup>nd</sup> day of August 2022 by and between the County of Tuolumne, a political subdivision of the State of California ("County") and Adams Ashby Group, Inc., a California corporation ("Consultant").

WHEREAS, on May 5, 2020, the County and the Consultant entered into a Standard Agreement for Professional Services ("Agreement") to provide NSP Consulting services for the Groveland Community Resilience Center Project; and

WHEREAS, the term of the agreement expires September 30, 2022;

WHEREAS, the completion of the Community Resilience Centers will be delayed from September 2022 to December 2022; and

WHEREAS, the County now requires extension of the Consultant's services related to the construction of the Community Resilience Centers to accommodate the delay; and




WHEREAS, Consultant submitted a proposal to extend the Agreement through the completion of the construction and monitoring process and to revise the Scope of Services.

NOW THEREFORE, THE COUNTY AND THE CONSULTANT AGREE as follows:

1. Paragraph 1 of the Agreement (Scope of Services) is amended as outlined on Attachment A to provide extended NDRC Consulting services related to the construction of the Community Resilience Centers.
2. Attachment A attached hereto is added to Exhibit A of the Agreement.
3. Paragraph 2 of the Agreement (Time of Performance) is amended to extend the term of the Agreement from September 30, 2022 to March 31, 2023.
4. Paragraph 3 of the Agreement (Compensation and Reimbursement) is amended to add an amount not to exceed Forty Five Thousand and No Cents (\$45,000.00) as compensation for the added obligations to the Scope of Work.
5. Except as amended herein, all other terms and conditions of the Agreement shall remain in full force and effect.
