Significant Incidents

10/2/2023

On Monday, October 2nd, at approximately 8:42 PM, TCFD resources responded to a reported rollover vehicle accident in the area of Highway 108 and Chicken Ranch Road near the community of Jamestown. TCFD Engine 761 arrived and discovered a single vehicle had rolled down an embankment resulting in the need for a rope rescue. One additional engine was requested with a second rope rescue compliment. Engine 761 had to use hydraulic extrication spreaders to get the door open and remove the single patient from inside the vehicle. The patient was



loaded into a stokes basket, securely hooked into the rope rescue system, and hoisted up the steep embankment utilizing personnel on the haul team.



All career-staffed TCFD engines are equipped with and personnel trained on the use of rope rescue systems for patient rescues. Resources that responded were TCFD Engines 761, 561, TCFD Battalion 5, TCFD Training 4425, CAL FIRE Tuolumne-Calaveras Unit Engine 4486, Sierra Conservation Center Fire Department Engine 5810, Manteca District Ambulance-Tuolumne Division and CHP Sonora. One patient was flown by PHI Air-Med to a trauma center in Modesto. Complex incidents such as this showcase the successful automatic aid agreements that exist between agencies within Tuolumne County.

TCFD in the Community

Community Airport Day

On Saturday, October 7th TCFD Engine 631 and Groveland Community Services District Engine 781 participated in the Community Airport Day at the Pine Mountain Lake Airport. Crook Vegetation Management Program (VMP)

From October 5th through October 8th TCFD personnel assisted the CAL FIRE Tuolumne-Calaveras Unit with treating approximately 100 acres of the Crooks VMP with prescribed fire. This prescribed burn reduced understory vegetation and improved rangeland while most importantly enhancing the fuel break system around the community of Groveland.





Drug Store Project

On Tuesday, October 24th an engine from Tuolumne County Fire Department Mono Village Station 51 along with an engine from the CAL FIRE Tuolumne-Calaveras Unit Standard Station attended the Drug Store Project at the Motherlode Fairgrounds. This event is put on for 7th graders from all of the elementary schools located in Tuolumne County. Your TCFD firefighters explained the importance of being aware of the effects of drugs and also took the opportunity to show the students some of the tools and

equipment used by firefighters.





Sound the Alarm Campaign

On Saturday, October 29th your Tuolumne County Firefighters from Engine 791 and Breathing Support 795 partnered with the American Red Cross to install smoke detectors at residences in the Rambling Hills Estates. This campaign helps residents install free smoke alarms, create fire escape plans, and allows TCFD personnel to share fire safety information and answer questions. With the help of all participants, 45 smoke alarms were installed!
