# **Welcoming Remarks & Introductions:**

Paula Broveleit hosted the meeting- welcomed everyone. Attendees introduced themselves and some shared what aspect of emergency preparedness they are currently working on.

# **Coalition Member Spotlight**

Jackie Potts with Black Oak Casino was our Member Spotlight! She did an excellent job explaining the way the Tuolumne Me-Wuk Tribal promotes Self-sufficiency. As EMS Training Coordinator, Jackie provides a plethora of trainings to the entities of the Tribe. With Tuolumne County EMS, Jackie provides weekly trainings to First Responders that meet or exceed the state and local standards. In addition to that, she also partners with Adventist Health and is an American Heart Association Trainer, as well as American Red Cross Trainer. Furthermore, Black Oak Casino has over 130 team members that are certified to administer Narcan.

In March, they completed their first EMSA accredited program. 9 Team Members graduated from the program with outstanding scores! The average final exam was 95.49%! Great job! Jackie finished her presentation with the current changes and attractions coming to Black Oak Casino as well as the Tribe's continued commitment to the community.

#### **Health Fair Flu Clinic**

Denise Sanford presented information about the Tuolumne County Health Fair Flu Clinic, sharing that flu shots will be provided to those 6 months and older on Saturday October 26<sup>th</sup>, 2024 from 7:00am-2:00pm.

Katie Andrews added the requirement for all healthcare workers to receive the vaccine, or they must wear masks.

#### emPOWER Data

Data was presented to demonstrate the number of the Medicare-dependent population by Geography for Tuolumne County. The number of beneficiaries fluctuated, with a larger increase in the region of Sonora than other zip codes.
